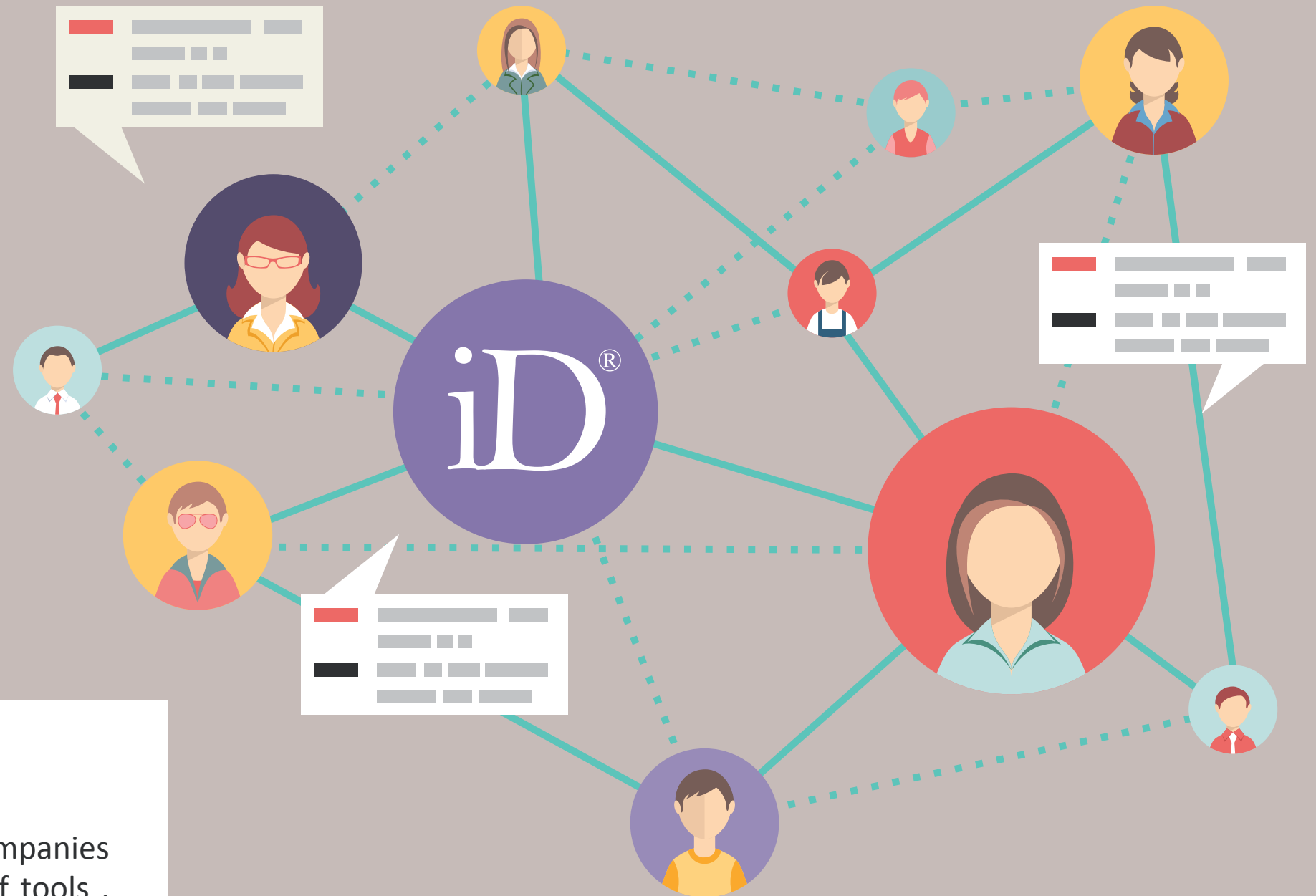


# TECHNOLOGY

### WHAT'S EXIMO IDRILLING?

eXimo IDrilling is software that enables service (tower) companies recording all the maneuvering in pit with detail on the usage of tools, motors, pumps, tubular, drills, etc.. organizing basic and fundamental information for the issuance of certificates that are billed to the operating companies.

Provides information from the operating part of the situation of company equipment, as also serves as a source to feed the asset management system for the issuance and maintenance of preventive maintenance routines (direct connection to eXimo IActivos) as fast reports electrical maintenance maneuvers or operational.

The software is aimed at service companies that want well-organized managing of their drilling, workover or pulling operations.

By customer request it could be possible to establish a support and maintenance service like the one that currently have all the eXimo products.

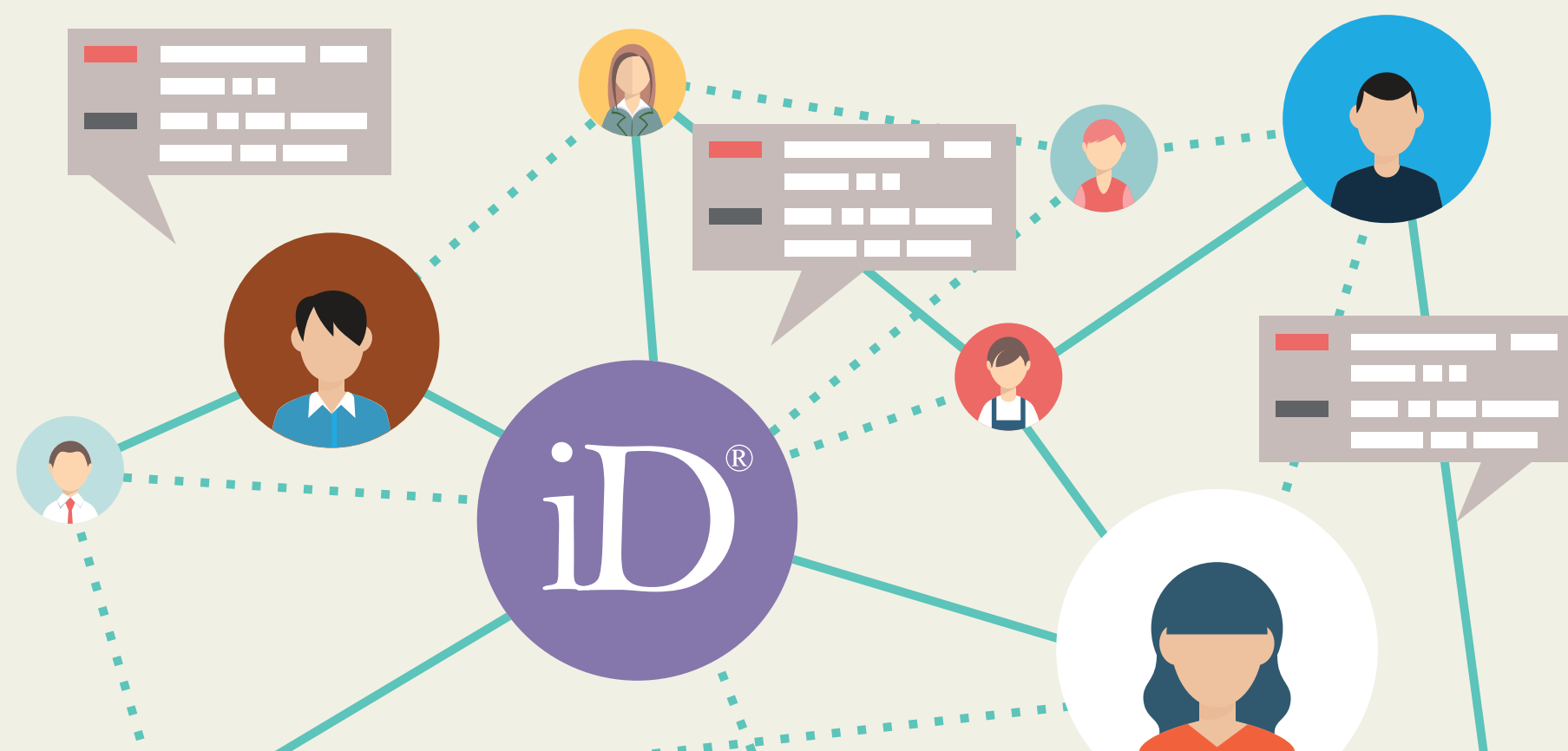
## CAN THE SOFTWARE BE CUSTOMIZED BY USER DEMANDS?

Only those companies that by particular characteristics require to have separated documentation in each headquarters will have to acquire more than one licence, each by individual payment.



## DAILY OPERATIVE REPORTS

Divided between Drilling Operations, WorkOver and Pulling.

Rig registry, areas, oilfields, clients (operators), drilled meters and esteemed. Pumps information, wick holder (Drill), Heavy Weight, Rods, trepans (different cuts), manoeuver details, gas-oil consumption, daily injuries, safety chats and concerning oilfield activity information.

## MANAGEMENT INFORMATION

Grouped by activity (Drilling, WorkOver and Pulling), economical, timetables ,etc.

## MAINTENANCE

Query operating hours of the elements that are utilized with data that identify them.(WIN and TAG).

Interface that allows to automate registration of working hours of the tool for routine maintenance.
